The Federal Aviation Administration (FAA) requires all drones that weigh between 0.55 pounds and 55 pounds be registered. Go to "[www.faa.gov/uas/getting\\_started/](http://www.faa.gov/uas/getting_started/)" to register your drone. Your drone must be registered to obtain a 1-year permit. All other permits will be 2 weeks. All other model craft are only allowed in River Bend Park, no permit needed.

I am assuming all risks whatsoever they may be whether hidden or, open and obvious, and hereby waive any and all rights I may have now or in the future as and/or against the Jefferson County, Missouri. I assume all risks.

I, the undersigned, rely solely upon my own judgment without influence by anyone in making this release and I fully understand and agree that it fully discharges all claims and damages whatsoever, known or unknown, and whether specifically mentioned or not.

All FAA rules and regulations governing the use of Drones, UMA, UAS or other flying craft shall be followed.

The Permit herein granted may not be assigned by the Applicant and an attempted assignment by said Applicant shall, at the option of the County, terminate the Permit granted herein.

This Permit may be revoked by Jefferson County at any time for any reason. Jefferson County, Missouri, accepts no liability and the Applicant herein assumes all risk and liability whatsoever they may be.
